



Rainbow Springs Art Festival Food Vendor Agreement

November 23rd and 24th, 2019

BOOTH SPACE ASSIGNMENT: You will be advised of booth space number by email. If not a truck, a tent or canopy are required.

BOOTH SIZE: Booth space is approximately 12 x 12. No sharing of booth space.

ELECTRICITY: Electricity will NOT be provided with a regular space rental. If electricity is needed, you may bring a QUIET generator.

SALES TAX: If applicable, vendors are responsible for collecting Florida State Sales Tax and sending to State Dept. of Revenue.

HEALTH CERTIFICATE: Food vendors must have a valid health certificate and have it with them during the event. If you do not have an annual one, please come prepared in case there is an inspection by the state. If there is a state inspector on site and a food vendor fails the inspection, the vendor must immediately correct the situation or leave the event and no refund will be given.

SET UP: May begin at 6 AM on Saturday, November 23rd. The Festival officially opens at 10 AM on Saturday, November 23. (I am sure we will have early birds, you may want to be prepared.)

All vendors are required to stay and maintain their display areas throughout the entirety of the event on November 23rd and 24th from 10 AM to 4 PM. You may stay open late on Saturday night, the street will remain closed to traffic.

BREAK DOWN: Should not begin until after 4 PM on Sunday, November 24th and must be completed by 6 PM. The street will open to traffic at 6 PM on Sunday 24th.

CLEAN UP: Vendors are responsible for cleaning up of their area and must not leave behind any trash or boxes. A dumpster will provided and it is expected that vendors place all trash in the dumpster. Boxes will need to be broken down before going into the dumpster.

WEATHER: Be prepared for rain, wind, sun, heat or cold.

RAIN DATE: There is no rain date scheduled for this event.

Application deadline: October 1, 2019. Vendor spaces are assigned in the order applications are received. No refunds once vendor fee is paid.

By the execution hereof, I/WE agree to hold the Rainbow Springs Art and its directors harmless from any and all damages, suits, claims, etc. arising from MY/OUR negligence or intentional wrong of any of MY/OUR employees, invitees or guests.
