Applications must include the following:

Completed application form. Include:

- Photographs: Four (4) photographs of artwork, including one photo of booth. Images must be clear.
- Registration fee.

1. Registration:

- Registration Deadline is Feb 15. Acceptance/non-acceptance will be emailed. No refunds after applicant is accepted.
- **Registration fees: Booth space is 10 x 10. Fee \$95 (RSA members, \$75)**

Late application After Feb 15 \$145

No applicants will be considered after March 1. No exceptions.

2. The Art Review Committee (ARC) reserves the right to refuse any entry deemed to be unsuitable. Registration Fee will be refunded.
3. Please describe art work and medium clearly on application.
4. All items for display or sale must be designed and handmade personally by the artists represented at the show, and from the artist on the application. **No resale items or items created from kits are allowed. Molds are only allowed for items like soap.**
4. This is an outdoor/tent show, rain or shine. ALL EXHIBITORS must be in tents. Exhibitors are required to exhibit within their allotted space. Fire and Safety code does not allow any exhibits to extend past the confines of the tent. No exhibits may extend into the street, or past a ten-foot boundary. This includes chairs, awnings, or property of the exhibitor.
5. Booth spaces are assigned randomly. Set-up, takedown and designated parking will be strictly enforced. Arriving late or leaving early will not be allowed. Exhibitors leaving early will not be allowed to exhibit in future shows. Show hours are 10:00 am until 5:00 pm.
6. **Set Up/ Tear down**
Exhibitors set up hours are **Saturday 6 am to 9 am**. Please check if Friday night set up is available: 352-455-8547 or rsacoop2016@gmail.com
Exhibitors must check into the information booth, drop off supplies at their booth location, and then move vehicles to designated parking.
Exhibitors are asked to be ready for the show by 9:00 Saturday morning.

Dismantling and tear down is Saturday evening 5:00pm to 7:00 pm. **ALL EXHIBITORS ON W PENNSYLVANIA AVE AND EAST CEDAR STREET MUST BE VACATED BY 6 PM, no exceptions, as per police code and opening Route 40 and W. Pennsylvania Ave. to public traffic.**

8. Please, no pets.
9. No alcohol, cigarettes, cigars or e-cigarettes in the exhibit space at any time.
10. Moving, trading, or relocating assigned spaces is prohibited.
11. Electricity is not provided. Generators are prohibited except for silent generators.
12. You must provide your own tent, tables, and display. **TENTS MUST HAVE APPROPRIATE WEIGHTS (Minimum weight 40 lbs. per support) AFFIXED TO EACH CORNER BY THE FRAME FOR STABILITY. TENTS CANNOT BE FIXED TO THE PAVEMENT, AND CANNOT BE A SAFETY HAZARD TO PASSERSBY.**
13. Each exhibitor is responsible for the presentation of the booth space. RSA will not assume responsibility for an artist's loss or damage to booths, artwork, displays and any property of the artist. Exhibitors are responsible for the overall professional appearance of their booth. All trash must be removed from the exhibitor's space upon leaving.
14. Overnight security will be provided Friday night.
15. All exhibitors are responsible for collecting and mailing state sales tax (7%) .
16. **CANCELLATION AND WAITING LIST POLICY:** There are no refunds for exhibitors' cancellations. After February 15, a waiting list may be established on a first come/first served basis, or by the discretion of the ARC. There will be no acceptance after March 1 for any exhibitor or vendor.
17. **COVID 19 POLICY** It is possible that Covid sanitation and safety procedures may still be in place for this festival. Each Exhibitor will provide hand sanitizer at the booth. Masks are recommended, and gloves are suggested if artwork needs to be handled. Exhibitors agree to adhere to the policies set in place by Rainbow Springs Art during the festival.
18. Cancellation of Festival due to pandemic: All fees will be refunded to exhibitors.
