Rainbow Springs Art is bringing awareness to the history of Dunnellon by depicting more than seventy historical buildings in the Village through the individual visions of local artists. All mediums are welcomed. Artists will choose a historical building within the Village and may create artwork according to his/her unique style and concept.

**The Historical Village is from W Pennsylvania Avenue north to McKinley Street, and from Cedar Street East to Route 41.**

**Application:** Artists are to submit their application, which states the address or location of the building they are honoring, a non-refundable jury fee and email a digital image of their work for review by the Art Committee jury. Artists may submit up to 2 pieces.

**Jury Process and Deadline:** Application and image must be submitted by **October 15**. No late entries will be accepted. Artwork Image must be emailed to [rsacoop2016@gmail.com](mailto:rsacoop2016@gmail.com). for jury consideration. Please submit in jpeg or png format only. Jury results will be announced October 21. Accepted artists will be emailed.

**Accepted Art:** All forms of original art (no prints) will be considered. Once accepted, artwork must meet the standards of the Art Show and be gallery ready for presentation.

2D art must be wired for hanging. No sawtooth hangers, staples, twine, string, etc.

3D art- please inform the Committee of any display considerations you have. RSA will accommodate 3D art to the best of ability.

The Art Committee reserves the right to place, hang and arrange artwork for the best interest of the show.

**Art Drop Off: All accepted art is dropped off at the gallery 20804 W Pennsylvania Ave on Wednesday October 25 from 10 am to 4 pm.**

**Sold Artwork:** All accepted pieces will be considered for sale. The artist will retain a 50% commission on any sold work. Reimbursement for a sale will be issued by December 15 2023. RSA collects sales tax and absorbs any credit card fees.

**People's Choice Award:** Visitors will receive a ballot and vote for their choice of Best in Show. Voting is from Nov 1 and ends November 25 at 3 pm. Winning Artist is to receive a \$200 cash prize.

**Removal of Art: All art is to be removed on Wednesday December 13 and Thursday December 14 from 10 am to 4 pm.**
