Rainbow Springs Art is inviting all artists, creators, students of any RSA classes, young artists and anyone who loves art to participate in the "It's a Small World" 6x6 Art Show. All art must be no larger than 6 inches in any direction. ALL MEDIUM will be considered RSA will provide two 6x6 canvases to the first 50 artist applicants. Applicants may submit up to 5 works.

Application: Artists may stop in the gallery Tuesday to Saturday June 1 to September 1 from 10 am to 4 pm to pick up their complimentary canvases. Two canvases will be distributed to the first 50 artists. Subject to availability, limit two per artist. Artists may also create on their own choice of substrate. All art must not measure more than 6 inches in any direction.

Entry fee is \$6.00 per piece.

Deadline: Wednesday October 16 with completed application form.

Art Drop Off: All art is dropped off at the gallery 20804 W Pennsylvania Ave on Wednesday October 16 to Saturday October 19. No late submissions accepted.

Accepted Art: All forms of original art (no prints) in any medium will be considered. Subject is the artist's choice. No political, derogatory or offensive material accepted. The Art Committee reserves the right to deny an entry if deemed not in the interest of the art show.

2D art (Painting, canvas, paper art) **must be wired** for hanging. No sawtooth hangers, staples, twine, string, etc. A frame is optional, but art should be neatly presentable. Textile art or mixed media must be prepared to hang securely.

3D art- please inform the Committee of any display considerations you have. RSA will accommodate 3D art to the best of ability.

The Art Committee reserves the right to place, hang and arrange artwork for the best interest of the show.

Sold Artwork: All artwork is considered for sale. The artist will retain a 50% commission on any sold work.

Reimbursement checks will be issued by December 20. RSA collects sales tax and absorbs any credit card fees.

ALL SOLD ARTWORK IS TO REMAIN IN THE SHOW UNTIL December 14.

People's Choice Award: Visitors will receive a ballot and vote for their choice of Best in Show. Voting is from November 1 and ends December 14 at 3 pm. Three Winning Artists are to receive a \$60 cash prize. In case of a tie, the Art Jury Committee reserves the right to a draw. All results are final.

Removal of Art--All art is to be removed on Wednesday Dec 17 to Friday Dec 20. PLEASE NOTE THE GALLERY WILL CLOSE FOR THE HOLIDAY WEEK ON DECEMBER 21. ALL ART MUST BE CLAIMED BY DEC 20.
